With its breathtaking architecture, iconic landmarks, and rich cultural heritage, Vienna has inspired countless artists and intellectuals throughout history. Musical luminaries from Mozart and Beethoven to Mahler and Strauss walked these streets, as did artists and intellectuals as recognizable as Klimt and Freud. Today, Vienna boasts vestiges of the Habsburg Empire, including the opulent Belvedere, Hofburg, and Schonbrunn Palaces, plus artistic treasures beyond compare. The historic center of the city is home to the celebrated Kunsthistorisches Museum and the Musikverein, and modern Vienna has developed a world-renowned coffee house culture and a culinary scene supported by abundant cafes, restaurants, and taverns serving delicious food and wine.

Our tour includes visits to many important landmarks, including the Ring Road, and a performance by the Vienna Boys Choir. We'll also venture away from the city for a day in the Danube and Wachau Valleys, where we will visit Dürnstein and Krems, historically important trade route towns, and the Cradle of Austria, Melk, home to a Benedictine Abbey in operation since 1089. An optional tour explores the subterranean Seegrotte by boat.

With its rich history, vibrant culture, and warm hospitality, Vienna offers an unforgettable travel experience for anyone seeking to immerse themselves in the beauty and charm of one of Europe's most beloved cities.

ITINERARY

Day 1: Fri Sep 27, 2024 - Departure from the USA

Embark on a memorable journey as you depart for Vienna on an overnight flight.

Day 2: Sat Sep 28, 2024 - Vienna:

Upon arrival at Vienna International Airport, you will proceed to the baggage claim area where your local Jet Vacations representative will greet you. You will be transferred to your hotel where you can freshen up and begin your exciting adventure in Vienna. The Austrian capital, known for its green parks, elegant stores, theaters, and gracious boulevards, is a city of immense beauty and cultural richness. Vienna is a center for classical music where illustrious composers such as Strauss, Beethoven, and Mozart created some of their most renowned masterpieces. The city's musical traditions are kept alive by its opera and several orchestras. Take the time to explore Vienna's splendid monuments and museums that celebrate the memory of The Habsburgs. Day 3: Sun Sep 29, 2024 - Vienna:

After breakfast, we embark on a full-day tour that offers a glimpse into Vienna's imperial history. Travel around Vienna's famous Ring Road, which was laid out on the site of the old city fortifications. Admire the architectural styles of numerous structures such as the Opera House, Fine Arts Museum, Natural History Museum, and City Hall, all of which can be found on Ring Road. We will then visit the Schonbrunn Palace, a magnificent summer residence of The Habsburgs that was originally constructed for Maria Theresa of Austria. The palace was also the meeting place for John F. Kennedy and Nikita Khrushchev in 1961 for a joint moon program. In the afternoon, enjoy some leisure time to relax or explore Vienna on your own. (B, L)

Day 4: Mon Sep 30, 2024 - Vienna/Danube Valley/Vienna:

After breakfast, embark on a scenic drive to the Danube Valley and picturesque Wachau Valley. We'll drive along the Danube River as it winds its way past charming old villages and steep vineyards. This romantic land is filled with history and legends, and the old castles highlight the former importance of this trade and traffic way. Later that day, we'll gain a different perspective as we embark on a relaxing afternoon boat ride of this historic area. This day will also include a visit to Krems, the heart of the Wachau's old vine merchant and Melk's magnificent Benedictine Abbey, a pearl of the Austrian Baroque. Return to Vienna in the evening and enjoy some leisure time. (B)

Day 5: Tue Oct 1, 2024, 2024 - Vienna:

Join us for a full day cultural tour of Vienna, starting with a delicious breakfast followed by an enlightening lecture at the hotel. The highlight of the day will be the enchanting Vienna Boys' Choir accompanied by the Viennese Chamber Orchestra. Be swept away by the unforgettable melodies of Mozart, Beethoven, Schubert, and Strauss. After the concert, we will take a guided walking tour of Vienna's old city, retracing the footsteps of Empress Elizabeth, affectionately known as "Sisi" by millions. Begin the tour with a visit to the Imperial Crypt, the burial place of the Habsburgs, before moving on to the glittering Hofburg, the official residence of Empress Elizabeth and Emperor Franz Joseph. The Hofburg showcases the grandeur and opulence of the Habsburg era and is a testament to the empress's charm, natural grace, and intelligence. As one of the world's foremost female equestrians, Sisi's love for horses is celebrated in Vienna's famous "Lippizaner horses," where you can witness the Spanish School of Riding at the Hofburg. Lunch will be served at a local restaurant, and the evening is yours to enjoy at leisure. (B, L)

Day 6: Wed Oct 2, 2024 - Vienna/Vienna Woods (Optional Tour)/Vienna:

After a sumptuous breakfast, spend the day at leisure and immerse yourself in the Viennese coffeehouse culture, chatting with the locals. Alternatively, embark on an optional tour to explore the picturesque southern part of the Vienna Woods, including a visit to the Mayerling hunting lodge and a boat ride on the largest subterranean lake in Europe, the Seegrotte. On the tour, you will pass through the romantic valley of Helenental and the medieval cloister, where the remains of the last Babenberger are housed. The tour ends with a leisurely cruise on Europe's largest subterranean lake, before returning to Vienna via Liechtenstein Castle. Tonight, join us for a farewell dinner. (B, D)

Day 7: Thu Oct 3, 2024 - Vienna/USA:

Enjoy breakfast before transferring to the airport for your return flight home. We hope you leave Vienna with fond memories and the desire to return soon.

- Baggage handling at the airport for your arrival and departure. (Based on one bag per person)
- Services of a professional tour manager and local host throughout the program

by June 27, 2024. Reservations and room availability are based on a first come, first served basis.

Passenger Cancellation Policies: No charges other than the non-refundable initial service fee/deposit are levied for individual passengers canceling up to 121 days prior to the commencement of Jet Vacations LLC services.
